The product may have the following additional risks:

Physicochemical dangers: Fertilizers are not combustible but they can help combustion even in the absence of air. When heated strongly they melt and can decompose releasing toxic gases containing nitrogen oxides and ammonia and depending on the mixture hydrogen chloride, sulfur oxides and phosphorus oxides. They have a high resistance to detonation. Heating in very confined spaces can lead to explosive behavior.
